Certain Demonstrator, rental, lease, and other used machines may be eligible for a portion of a new unit warranty, but that does not mean that a machine is new or unused. The warranty period ends when either the year/month or machine hour limit is reached, whichever limit occurs first.

The Owner's Responsibility: The Toro warranty will become void if the owner does not perform the required maintenance at the recommended times as outlined in each machine's operator's manual. Toro or Toro approved service parts must be used for maintenance. Additionally, the owner will pay for all freight, transportation, and travel expenses related to any warranty repair.
